### 1 Introduction

Motadata has a powerful engine that collects the information from your network and process it to alert you in critical cases. Motadata along with the engine uses different components (GUI, storage device, memory etc.) so you can conveniently use Motadata through a simple user interactive screen.

Based on the network and its requirements, Motadata offers following types of installation.

- Standalone Server
- Distributed Server (Standalone + RPE Server)
- HA Server (Standalone + Standalone)

### **Important Points!**

- The CPU should support SSE 4.2 (or higher) instruction set. (Read more: <a href="https://groups.google.com/forum/#!topic/clickhouse/mjNwX\_OtsZM">https://groups.google.com/forum/#!topic/clickhouse/mjNwX\_OtsZM</a>)
- For deployment over WAN, **2 MBPS** bandwidth should be available between Master and RPE.
- In hardware calculations, Assumed Cores are Virtual Core. When you calculate the Physical Core so please consider 1:2 Ratio for core calculation

### 2.3 Log Events

In Motadata, DB Storage requirement per log Event is 100 Bytes. Based on this, use the following table to identify suitable hardware size for up to 1000 Logs/Second.

For more than 1000 EPS (up to 8000 EPS) we need additional (4 Core/4 GB RAM/Additional data storage in Master) for every 2000 EPS log. For Example, 8000 Logs/Second, you will need 4 Log RPE Machine with each machine having configuration of (4GB/4 Core/Additional data storage in Master).

### Assumption:

- 1) The Total disk space for Logs can be calculated based on actual retention period requested in the deployment.
- 2) The average size of the Event is considered as 100 bytes. In case it is more than 100 bytes, than EPS is considered in multiple of 100 bytes. Suppose the Average Event size is 180 bytes, then single event is considered as two events.
- 3) Full text search should be kept off.
- 4) RTT Should be less the 500 ms
- 5) Above HW assumption is based on syslog.
- 6) For windows logs above configuration will work for 800 EPS\*
